Update on policing issues (Danielle), status homelessness sweeps/enforcement; new captain Michael Ord from Central has homeless force, closing down streets Thursday & Saturday > move across the street and back, has promised will continue till they don't come back; hazmat, public health issue being addressed; in Silver Lake high profile crime areas swept and did move back, decriminalization of lack of housing issue but number of arrests belay, need to address sanitation issue, need to be sent out with police to protect, sidewalks should not be blocked, need to put permanent housing in place, what progress has been made; problem of the fringe people who are not homeless and prey on them; use Olympics to leverage affordable housing to deal with homeless situation; 5611 amended to give police more power to confiscate & destroy leads to more lawsuits, storage backpack & 60 gallon storage; more effective outreach; federal issue bad trade agreements > loss of jobs; mental health issues; rapid rehousing; Need to frame in economic turms
